DISCUSSION/INFORMATION ITEMS

A. The Board’s Role in the Educational Outreach Effort for the Override

Dr. Nat White gave the Board a brief update on the activities the College has been going through as part of the educational outreach process. Dr. White encouraged the Board to provide their input on this process to Dr. Colleen Smith and Ms. April Sandoval. Dr. Nat White suggested many ways the board could be involved such as: placing a CCC sticker on your vehicle; talking to people in the community; and being involved in community outreach presentations. Dr. White encouraged everyone to go out of their way to help promote the College’s efforts.

Mr. Shaun McKernan is setting up educational outreach presentations. One or two Board members will participate in each of the community outreach presentations. It is important for Board Members and staff members to be as involved as they can be in this process.

We will send additional information on this effort as it becomes available so that the everyone is able to give consistent answers to questions for the effort. The Board would like any information for this effort to be clear, concise, full of positive information, consistent, and easy to use.
