

Agreement to Pay Tuition Charges and Understanding of Coconino Community College Student Account Receivable Procedures

Billing Statements:

I acknowledge that I may not receive a paper bill statement from Coconino Community College and it is my responsibility to check my online student account for tuition and fee statements and balances, as well as the deadlines, refund dates and fee information.

Dropping/ Withdrawing from Courses:

I understand that I am responsible for dropping courses I do not plan to attend. If Coconino Community College drops my courses for non-attendance, I am responsible for the “no show” fee at the current per credit hour no show rate as adopted by the District Governing Board. Classes can be dropped for non-attendance as early as the first day of class and the no show fee will apply.

I am responsible for all tuition and fees for courses I have registered for, regardless of my payment status. Courses I have attended must be dropped during the 100% refund period or tuition and fees will be assessed according to the refund schedule.

Agreement to Pay Tuition Charges

In consideration of Coconino Community College allowing me to register for courses, thus incurring the attendant costs to Coconino Community College, both direct and indirect, I promise to pay the tuition and fees assessed to me for courses for which I have registered by the published payment due dates for each semester. Also, I agree to pay for any additional fees and interest charges that are assessed to my account each semester. I further understand and agree that any unpaid tuition and fees may be treated as an educational loan under federal law and may not be discharged in bankruptcy.

In the event of default of any of the terms of this agreement, I hereby give to the Coconino Community College Dean of Finance, or his/her designee, Power of Attorney to apply all monies owed to me from Coconino Community College to any delinquent portion of my account until the principal fees, interest and costs are paid in full. I agree that Coconino Community College may repay my account balance from any financial aid funds due me. I understand that the principal amount is calculated based on my class load each semester at Coconino Community College.

I also understand and acknowledge that all outstanding account balances attributable to “qualified higher education expenses” are considered “qualified educational loans” under Internal Revenue Code Section 221 (as those terms are defined in 26 U.S.C. § 221) and are an extension of credit to me based on an express to repay Coconino Community College in the future. I further understand that my acceptance of these terms constitutes an acknowledgement and acceptance that my account balance qualifies as an education loan and cannot be discharged under the federal bankruptcy code, except in cases of undue hardship. 11 U.S.C. 523(a)(8).

In the event I default on this agreement and it becomes necessary to place this account for collection, I also agree to pay collection agency fees, up to 33.33% of the original principal balance, plus any court and/or reasonable attorneys' fees resulting from the enforcement of this agreement. Any collection fees stated above are in addition to the principal, fees and interest due on my account.

As further part of this agreement I also understand and agree and authorize Coconino Community College to use my social security number for internal and external credit reporting and collection purposes for all charges incurred against this account for the duration of my enrollment at Coconino Community College.

If there is a dispute or problem with this agreement then the College will follow the law of the state of Arizona, without reference to any conflicts of law principles.

I hereby authorize Coconino Community College and/ or its agents, including attorneys and/or collection agencies, to contact me via cellular telephone and/or all forms of electronic technology (to include text messaging and e-mail), unless I notify such party in writing to cease such communication.

This agreement I enter at my own will and this agreement shall be governed in interpretation and enforcement at all times by the laws of the State of Arizona (excepting provisions governing conflicts of laws).

I have read, understand and agree with this Agreement to Pay Tuition Charges and Understanding of Student Account Receivable Procedures. All information that I have provided is correct to the best of my knowledge.
