PRESENTATION OF PROPOSED PROPERTY TAX INCREASE

Ms. Jami Van Ess presented the proposed property tax increase.

The primary tax rate for 2015/2016 is as follows:

Primary Tax Rate	2015/2016
Net Assessed Value (NAV)	\$ 1,537,418,218
Allowable Levy	\$ 7,478,002
Tax Rate per \$100 primary NAV	.4864

Fiscal year 2015/2016 will be the seventeenth year that the District will be required to levy a secondary tax for the retirement of indebtedness incurred by the January 7, 1999, 20-year, \$25,000,000 bond sale. The secondary tax rate for 2015/2016 is as follows:

Net Assessed Value (NAV)	\$ 1,602,339,912
Debt Services Required	\$ 1,989,246
Tax Rate per \$100 primary NAV	0.1241
