PRESENTATION OF PROPOSED PROPERTY TAX INCREASE

Ms. Jami Van Ess presented the proposed property tax increase.

The proposed primary tax rate for 2017/2018 is as follows:

Primary Tax Rate	2017/2018
Allowable Levy	\$ 7,939,000
Tax Rate per \$100 primary NAV	0.4816

Fiscal year 2018 will be the nineteenth year that the District will be required to levy a secondary tax for the retirement of indebtedness incurred by the January 7, 1999, 20-year, \$25,000,000 bond sale. The secondary tax rate for FY 2018 is as follows:

Secondary Tax Rate	2017/2018
Debt Services Required	\$ 2,185,250
Tax Rate per \$100 primary NAV	0.1326
