# 1. DISCUSSION/INFORMATION ITEMS

## A. Federal Policy Updates – President Eric Heiser

President Heiser briefed the Board on how the College is addressing federal policy updates during weekly Cabinet meetings. Faculty Senate President Doug Friedman, Staff Council Chair Alimah Damgaard, and Sonni Marbury attend the federal policy update segment of each Cabinet meeting to relay pertinent information to their respective groups. He noted that the Cabinet is proactively monitoring potential cuts to the Department of Education and anticipatory reductions in federal student funding. Plans are being developed to support both students and grant-funded staff in the event of such cuts.

#### The Board Discussed:

- How the College receives federal policy information (e.g., AACC, ACCT, AC4)
- Employee access to reliable news sources via the College's SharePoint
- Weekly meetings of the ten Arizona community college presidents to discuss state and federal developments
- Opportunities to engage with Senator Kelly and Senator Gallego
- Appreciation from Chair Smith for the Cabinet's transparent and thoughtful handling of federal updates
- Ensuring CCC remains a safe, inclusive, and welcoming space for all students prior to launching new programming

The Board's role in supporting the College through these transitions

# 2. Rethinking Strategic Enrollment Management at CCC through 4DX and Achieve the Dream – Mr. Tony Williams

Mr. Williams presented an overview of CCC's strategy to enhance student enrollment through the implementation of the 4DX framework and the Achieve the Dream initiative. See the March 19, 2025 documents file for additional information.

#### The Board Discussed:

- Interest in having Alex Purchase present at a future Board meeting on Dual Enrollment activities across districts
- Collaboration between CCC's Dual Enrollment staff, students, and high schools to create clear pathways to CCC
- Remarkable retention of three out of four Pell Grant recipients—positively impacting 583 students
- The powerful role of Foundation scholarships in supporting Pell-eligible students
- The importance of retraining programs if the economy enters a recession
- Low completion rate (20%) of FAFSA among CCC students compared to the national average (over 50%), and efforts underway to address this gap
- Promoting CTE programs that do not require a degree
- Providing support for students whose parents refuse to participate in FAFSA
- Enhancing the website with simplified and accessible financial aid information
