Dr. Van Ess reviewed the budget status report with the Board. The report details expenses through December 31, 2024, which is 50% of the current fiscal year (FY). Please see the January 27, 2025, documents file for additional details.

Dr. Van Ess, Dr. Heiser, and the Board discussed the FY26 budget and the Informed Budget Process (IBP). Topics included the FY26 budget forecast, tuition and fees (including out-of-county and differential tuition), compensation, IBP requests, and Board direction. Please see the January 27, 2025, documents file for additional information.

Board Direction

After discussing the budget items, the Board:

- Is Comfortable moving forward with the presented differential tuition due to increasing costs of supplies to the College
- Would like to see \$4, \$5, and \$6 option comparisons for tuition increases and how an increase would affect individual students and the amount they pay out of pocket
- Would like to see what percentage of the students are paying increased tuition that would not be covered by loans and grants
- Would like to see how many people in programs with differential tuition are grant and scholarship students and what percentage of people in that group would be affected by an increase in tuition
- Would like information on cost of living comparisons between Flagstaff and other areas of the state
- Would like Dr. Van Ess to analyze the College's projected revenue increases versus expense increases to understand the impact of potential compensation increases
- Would like data on how employees utilize the cafeteria plan funds, such as the percentage used for dependent medical expenses versus other purposes
- Would like to see the same compensation and cafeteria plan options brought back for further discussion

The Board thanked Dr. Van Ess and her team for their work on tonight's budget presentation.
