ADOPTION OF AGENDA

Vice Chair Hurley made a motion, seconded by Trustee White, to approve the agenda as presented. The motion was unanimously approved (Trustee Eikenberry, Trustee Garcia, Vice Chair Hurley, Chair Smith, and Trustee White voting in favor).

ADOPTION OF PROPOSED 2026/2027 BUDGET and PRIMARY PROPERTY TAX LEVY and RATE –

Dr. Van Ess

In accordance with A.R.S. §42-17151, the District Governing Board is required to set the property tax rate each year. The District may levy the maximum 2% increase allowed, provided that the truth in taxation notice and hearing have been followed according to A.R.S. §15-1461.01.

Dr. Van Ess explained that although the maximum allowable levy increases due to statutory growth and new construction added to the tax rolls, the tax rate decreases because assessed property values have increased at a greater rate than the levy. The proposed levy is incorporated into the College's fiscal year 2026–2027 budget. The Primary Property Tax Levy and Rates for FY27 were calculated as follows (FY26 is shown for comparison only):

Vice Chair Hurley made a motion, seconded by Trustee White to approve the fiscal year 2026-2027 primary property tax levy as presented by roll call vote.

CALL TO THE PUBLIC

Mr. David Spence, Flagstaff City Councilmember speaking as a private citizen, addressed the Board regarding the potential use of heat pump technology in future College construction projects. He discussed energy efficiency, long-term operating costs, workforce development opportunities, and environmental considerations associated with modern heating and cooling systems.

Mr. Brian Blue, CCC Foundation Board Chair addressed the Board and expressed appreciation for the College's positive impact on the community, students, and workforce development efforts.

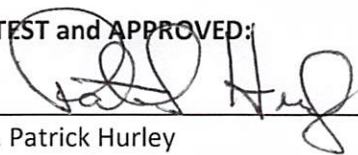

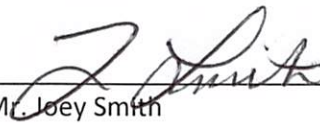
