**RETREAT DISCUSSION**

The District Governing Board participated in Day Two of its annual retreat to review Board governance practices, receive training on Arizona Open Meeting Law requirements, discuss Board effectiveness, and establish priorities for the upcoming year.

**ARIZONA OPEN MEETING LAW AND BOARD ROLE TRAINING - Dr. David Borofsky**

- **Open Meeting Law Training**  
The Board participated in a review of Arizona Open Meeting Law requirements and governance best practices. Trustees discussed Board member responsibilities related to public meetings, communications, transparency, and accountability, and emphasized the importance of maintaining public trust through compliance with state laws and effective governance practices.
- **Board Governance and Effectiveness**  
The Board participated in a discussion regarding effective governance practices and Board responsibilities. Discussion focused on strategic leadership, policy oversight, fiscal stewardship, and supporting student success. Trustees emphasized the importance of collaboration, effective communication, informed decision-making, and maintaining a clear distinction between governance responsibilities and day-to-day College operations. The discussion also reinforced the Board's commitment to advancing the College's mission and serving the needs of students and the community.

- Support Data-Informed Decision-Making

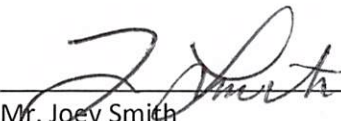
## **ADJOURNMENT**
