## 1. FOLLOW-UP ITEMS – Chair Joey Smith

### 2. DISCUSSION/INFORMATION ITEMS

#### A. Achieving The Dream (ATD) Core Team Update - Ms. Dianna Sanchez

Ms. Dianna Sanchez updated the Board on the College's progress with Achieving the Dream (ATD). The Core Team attended the ATD Kick-Off event in New Orleans this summer, in Louisiana, where they learned how working with ATD will improve student success over the next three years. ATD emphasizes data-informed decision making, institutional transformation, and a strong focus on equity. See the August 28, 2024, documents folder for additional information.

### The Board discussed:

- The benefits of belonging to ATD
- Institutional transformation is the result of data-informed decision making
- The limitations of federal data reporting, particularly the IPEDS report, which only captures full-time students
- The Aspen Institute and AACC's efforts to influence Congress to use more comprehensive metrics for judging institutions.
- The focus on equity and serving different groups of students, emphasizing increased opportunity and access that address demographic and cultural issues, while focusing on equity and serving different student groups

#### B. Summer Camp Update – Ms. Dianna Sanchez

Ms. Dianna Sanchez spoke about the \$100,000 Northern Arizona Regional Behavior Health Authority (NARBHA) Foundation gift to support the June STEAM summer camps for rising 6th through 9th graders. Camps were offered at various locations, including Lone Tree, Fourth Street, and Flagstaff High School, and were free for participants. The NARBHA Foundation has agreed to continue funding the camps in 2025 and pledged additional funding to allow for an extra month of camps. #### The Board discussed:

- Camp registration statistics
- The popularity of specific camps, such as woodworking, culinary, and coding, which had significant waitlists
- The opportunity for the summer camps to be held in other locations, such as Williams
- The value of the students coming to campus and introducing them to what the College has to offer and helping them envision themselves going to college

#### C. Budget Discussion - Dr. Eric Heiser

Dr. Eric Heiser discussed the Board Retreat discussion surrounding changing the format of Work Sessions to include budget information starting earlier in the year and reports from the College, such as the President's Cabinet presentations or students, faculty, or staff, with Board member interests being considered. This allows the Board to focus on areas of the College they want to hear about

#### The Board discussed:

- The importance of seeing all budgetary details and understanding the reasoning behind certain decisions and the importance of stewardship and understanding the budget details
- Out-of-county and differential tuition and how they affect the budget and student enrollment

#### FOLLOW UP:

- Consideration of investment interest being used for special projects and not rolling over into the general fund
- The Board will provide specific budget areas they want to be covered in advance of budget season and provide input regarding topics they would like presented at Board meetings
